



## OFFICIAL RULES

### "Best Margarita in Paradise"



#### Eligibility:

The contest is open to U.S. Residents. Contest is governed by the laws of the United States and void where prohibited by law. All federal, state and local rules and regulations apply.

Teams of up to four must have their prep area decorated and ready by 2:45am and be available to create and serve their margaritas between the hours of 5:30pm and 7:00pm on Saturday, June 19<sup>th</sup>. Each team will have their own designated 10ft. X 10ft. preparation area to decorate, mix, serve and enjoy for the day. Margaritas will be presented to judges between 5:30pm to 6:00pm. Free samples served between 6:00pm to 7:00pm. A plaque will be awarded to the "Best of Show" area.

#### Contest guidelines:

Each team will start with 4 bottles of Tequila, supplied by the Best Margarita in Paradise and Southern Wine and Spirits. There is not any minimum or maximum number of ingredients; however each team must supply all of the other ingredients to make margaritas with the 4 liters provided, including fruit\*, other liquor, etc. Please bring your own shakers and blenders if needed. Sample cups will be provided. Any leftover tequila must be returned to the contest organizers if not used in the margarita samples.

Each recipe must be submitted no later than June 5<sup>th</sup> with a picture of the team/individual. Please include the name of the recipe and ingredients.

**Between June 5<sup>th</sup> and June 11<sup>th</sup> you MUST email [bestcheeseburger@aol.com](mailto:bestcheeseburger@aol.com) to see if there are spots available and to be accepted! DO NOT MAIL ANYTHING until directed by a committee member.**

Originality in recipe names is encouraged. Please mark in registration form if electricity is needed during margarita preparation.

\* fresh fruit must be cut directly before mixing per health department rules.

**Judging:**

A pre-selected panel of judges will judge the recipe and margarita. Criteria for judging will be available to the teams upon registration. Decisions of the judges are final and binding. The winning team for the "Best Margarita in Paradise" will receive **\$250!** Awards will also be given for 2<sup>nd</sup> place, 3<sup>rd</sup> place, "Best of Show" and "People's Choice". The "People's Choice" will be awarded to the team with the most money in the fishbowl during public sampling. This money will also benefit the Northern Illinois Food Bank.

No substitutions or transfer of prizes is permitted. Any taxes are the sole responsibility of the winners.
